Sl. No.	The school is directed to ensure that :
1	The total number of sections for Bal Vatika shall be restricted to 03 (One each in Bal vatika I,II & III respectively). The total number of sections from classes I to XII shall be restricted to 16 of which not more than 1/3 rd shall be used for class XI & XIIth. However, any further increase of sections shall strictly be subject to prior and specific approval of the Board as per the provisions of affiliation bye laws and availability of required infrastructure and rooms of 500> sq. ft. dimension.
2	Composite science lab is not properly laid out.Instead of separate bio, chem and physics sections, it is laid out as a chemistry lab.No work stations (without stands) for bio and no lab standard tables for physics are seen.Fire extinguishers, exhaust fans and first Aid kits are not seen.The school shall upgrade the composite lab as per Sop of the board within 3months and submit compliance on SARAS with videography.
3	Fire extinguishers and safety manuals for lab use are not made available in Biology and Chemistry labs. The chemicals and bases should be in locked storage area and there should be grills in window for safety concern. Physics lab has work stations with water sinks, in place of lab standard tables.School is directed to arrange and upgrade the labs with all recommended infrastructure as per SoPs vide circular dated

	04.10.2022 (no 11/02022) and upload the compliance within 03 months on SARAS portal.
4	Separate reading section for teachers and staff is not arranged in Library. School is directed to follow the circular no 11/2022 (SoPs for labs, library and sports) and arrange the separate section for teachers and upload the compliance on SARAS portal within 03 months.
5	The mathematics lab is also not developed properly as per Board guidelines. There only one work station and modules/charts and instruments are placed on slabs along the wall. Math lab should have proper work stations with recommended storage as per Board guidelines vide circular no 11/2022. School is directed to develop the math lab accordingly and upload the compliance on SARAS portal within 03 months with you tube video link.
6	The athlete track for Outdoor games is not properly made. It has sharp curves and obstructed by stairs from main school building. School should follow the Circular no 11/2022 and upgrade all the outdoor sports activities and upload the compliance with video link at SARAS portal within 03 months.
7	School is directed to ensure the mandatory training of its teachers from CoE, CBSE, Ajmer and upload the compliance on SARAS portal within 03 months.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII , as the case may be.

The approval of the Board as mentioned above, is subject to the following conditions:-

1. The school shall be responsible for its genuineness of the documents/ data/ information uploaded by the school. In case of any discrepancies, action will be initiated against the school as per Affiliation Bye -Laws-2018.
2. The school shall follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
3. The School shall apply online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
4. The school shall go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy thereof for reference purpose and is also advised to regularly visit CBSE websites i.e., <http://cbseacademic.nic.in/> & <http://cbse.nic.in/> for updates.
5. The school shall renew mandatory certificates from time to time.
6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
7. Concerned Regional Office is requested to create new email id of school as per direction issued by controller of examination. This E Mail ID is used for communication with CBSE only.
8. The school shall not remove the documents and videography links in the mandatory disclosure section of its website.
9. The school shall follow the SOPs of the Board for its Laboratories, Library and sports facilities issued by the Board vide circular no 11 dated 04.10.2022.

If the compliance is not submitted with in the stipulated 3 months , the Board may enhance the penalty amount and debar the schools from filling up registration/LOC details of students of classes IX to XII, as the case may be, in the next academic session i.e. 2024-25.
